1. All program fees must be paid in full prior to their start. Summer Camp spots are reserved with the deposit of \$160.
2. In order to be issued a make-up lesson, lesson cancellations require 24-hour notice prior to the start of the lesson. All make-up lessons must be used with the current session of programming. Should a lesson be canceled less than 24 hours prior, the lesson will be forfeited. Lessons are rescheduled when canceled on behalf of McNeil Equine (i.e. weather, coach illness).
3. Should a participant withdraw from camp prior to its start, the \$160 deposit is non-refundable. There are no refunds or reimbursements given should a participant arrive late, leave early, or withdraw from camp prior to the end of the session.
 4. Proper riding attire is mandatory. a. Long pants (typically jeans) – shorts, capris or PJ's are not acceptable. b. Boots with a heel of 1.5 cm are always required for riding. Open toe footwear is not permitted around horses. c. Avoid loose or baggy clothing, dangly earrings and bracelets.
5. ASTM certified riding helmets are always required when riding horses. McNeil Equine has a selection of helmets available for use.
6. Children not participating in programs must be supervised at all times.
7. Significant medical conditions and behaviour concerns are to be disclosed to McNeil Equine at time of registration.
8. Participants are to be polite, respectful, and willing to follow instruction. Unruly participants will be removed from the program.
9. Attendees are aware that aside from the horses, there are dogs and cats also on site. When arriving or departing, drivers are asked to drive slowly and watch for children and animals.
